## **STIPULATION AND ORDER TO EXTEND TIME**

Plaintiffs Aqua Connect, Inc. and Strategic Technology Partners, LLC (collectively, "Aqua" or "Plaintiffs") and defendants TeamViewer US, Inc. and TeamViewer Germany GmbH (collectively, "TeamViewer" or "Defendants") submit this Joint Status Report and Stipulation and Order to Extend time in the above-referenced consolidated cases.
