**ORDER GRANTING  
STIPULATION TO MODIFY  
SCHEDULING ORDER (Doc. 107)**

Before the Court is a joint stipulation (Doc. 107) filed by Plaintiff and Defendants to modify the operative Scheduling Order (Doc. 102) in this matter. The Court has previously granted three modifications in this matter where overseas discovery and depositions have been greatly complicated by the COVID-19 pandemic. In this latest request, the Parties inform the Court that the deposition of Chunhua Li, in his individual capacity and as the corporate representative for Defendants, was delayed by about a week due to COVID-19 travel protocols. The Parties fail to explain how this one-week provides good cause for the one-month extension they request here. The Parties fail to provide any other justification for

1 the requested extension. The Court finds good cause to extend the remaining  
 2 pretrial deadlines by **one week** and modifies the Scheduling Order AS FOLLOWS:
