ORDER SETTING CASE MANAGEMENT
SCHEDULE FOR '631 AND '302 PATENTS;
DENYING REQUEST TO LIFT STAY AS TO '597
AND '266 PATENTS

The Court is in receipt of the parties' Joint Status Statement filed October 9, 2020. (Dkt. No. 66.) Having carefully considered the matters therein, the Court **Orders** as follows:

- 1. The stay with respect to the '597 and the '266 patents remains in effect. The Court is willing to approve an accelerated schedule to reduce any potential prejudice once the IPR proceedings are concluded. In addition, due to COVID-19, the District may be backlogged on jury trials and a continuance may be unavoidable.
